1. The monthly stipend stipulated in the successful applicant's award letter will automatically be the "standard" amount shown in the above table. The accommodation estimate quoted by the prospective host supervisor at the time of application is for preliminary information only.

2. If an increase to the stipend is required due to more costly accommodation, the fellow can apply for an increase (within the maximum stipulated in the table). To do this, the fellow will need to provide written evidence of the actual cost of accommodation to the POGO Secretariat at least 3 weeks in advance of the fellowship start date.
3. If no request is received, and/or the fellow fails to provide the written evidence of accommodation cost prior to the fellowship start date, the stipend amount paid will automatically be the "standard" amount shown in the above table.
4. The fellow is required to provide all original accommodation receipts at the end of the fellowship.
5. If the cost of living for the city where the fellowship will take place has a cost of living index significantly different from the city/country average shown in the table, the stipend offered may be adjusted according to the Consumer Price Index of that city (<http://www.numbeo.com/cost-of-living/>).
6. If the host city/country is not included in the above table, the POGO Secretariat will calculate the appropriate stipend based on the Consumer Price Index (<http://www.numbeo.com/cost-of-living/>).
7. \* The average living cost and accommodation is provided as a guideline for USA. Should a successful candidate be hosted by an institute in the USA, the living allowance and accommodation allowance will be calculated on a case-to-case basis.
